

CITY OF WESTLAKE NOTICE OF EMERGENCY PUBLIC MEETING

NOTICE IS HEREBY GIVEN that on **Monday**, **March 30**, **2020**, the City of Westlake City Council will hold an EMERGENCY PUBLIC MEETING at 6:00 PM.

As a result of the Novel Coronavirus Disease 2019 (COVID-19) and subsequent declarations for National, State and Public Health Emergencies, the City of Westlake will conduct an **Emergency City Council Meeting** to discuss the following items:

1. State of Emergency Proclamation

A PROCLAMATION OF THE CITY OF WESTLAKE, FLORIDA, DECLARING A STATE OF LOCAL EMERGENCY DUE THE OUTBREAK OF COVID-19 ALSO KNOW AS CORONAVIRUS; PROVIDING THE CITY WITH POWERS, INCLUDING, BUT NOT LIMITED TO THOSE PURSUANT TO FLORIDA STATUTES, CHAPTER 252; PROVIDING FOR PENALTIES FOR VIOLATIONS; PROVIDING FOR CONFLICTS, SEVERABILITY, AND FOR AN EFFECTIVE DATE AND A TERMINATION DATE.

2. Emergency Ordinance 2020-03

AN EMERGENCY ORDINANCE OF THE CITY OF WESTLAKE, FLORIDA, AUTHORIZING THE CITY MANAGER TO MAKE PROVISIONS FOR ELECTRONIC ATTENDANCE BY ELECTED AND APPOINTED OFFICIALS AT CITY MEETINGS DURING PERIODS OF A DECLARED PUBLIC HEALTH EMERGENCY; PROVIDING FOR PUBLIC PARTICIPATION BY TELEPHONIC OR ELECTRONIC MEANS; PROVIDING FOR AUTOMATIC DELAY OF FINALITY OF OFFICIAL ACTION PENDING PUBLIC COMMENTS; AND PROVIDING AN EFFECTIVE DATE.

The meeting will be held in a modified manner. The following specific information is provided as to the March 30, 2020 Emergency City Council Meeting:

- 1. The meeting will take place at the Westlake Community Center/City Council Chambers located at 4005 Seminole Pratt Whitney Road, Westlake, Florida, 33470. In keeping with social distancing, and limiting gatherings to no more than 10 persons, the meeting space will be closed upon meeting that capacity.
